**All products must be approved by the host and director before being offered for sale! The Director and Host reserve the right to pull any products that have not been pre-approved. There is a nonrefundable \$55 entry fee and a 20% commission collected on all sales and orders made during Christmas in the Country. (Commission on sales over \$2000 drops to 15%). Returning artists that register by end of show on Sunday will receive a discounted entry fee of \$45. Entry deadline is Sept. 30. If you miss this deadline, your information and name will not be listed in the pull out tabs that are printed and inserted in the papers or our tri-folds.** Your returned paperwork will secure your spot.

**\*\*The commission is paid to the host on Sunday at the end of the event.** Participants must have a UBI# to report sales tax. You may acquire a UBI# at [www.dol.wa.gov/forms/700028.htm](http://www.dol.wa.gov/forms/700028.htm) Guests need to be present to sell their work and may not have their products for sale in another show on Bainbridge Island the same weekend.
